This correspondence will provide you with the billing rate for Peach Lake (Vails Grove) Sewer District during the 2017 calendar year. Please retain this information for your records.

For tax preparation purposes, your portion of the interest paid during 2016 on the debt for the sewer was \$383.58. Please consult with your tax advisor as to the deductibility of these costs.

For 2017, the sewer rates will remain the same as outlined below until a financial reconciliation and audit is completed with the Town of North Salem and NYS DEP. Once the Town has completed the reconciliation, determination on the rates will be completed which may result in an adjustment to your rate.
