



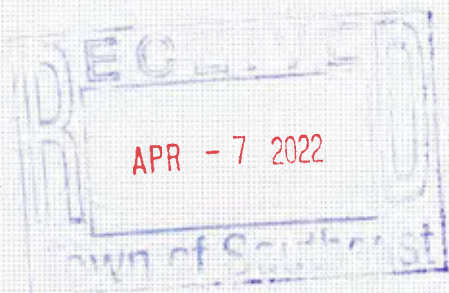

**SOUTHEAST PLANNING BOARD NOTICE
OF PUBLIC HEARING**

PLEASE TAKE NOTICE that the Planning Board/Architectural Review Board of the Town of Southeast, New York, in accordance with Chapters 78 and 138 of the Code of the Town of Southeast, and NYCRR Part 617 of the Environmental Conservation Law (as applicable), will hold a Public Hearing on **Monday, April 11**, continued from March 28, 2022 at 7:00 p.m., at Southeast Town Offices, 1360 Route 22, Brewster, New York to consider the following:

LINCOLN LOGISTICS BREWSTER (p/k/a Commercial Campus at Fields Corner) – Application is being made to amend the Site Plan and Wetland Permit of the previously approved Commercial Campus at Fields Corner project located at Rte. 312, Pugsley Road and Barrett Road in the OP-3 and RC Zoning Districts of the Town of Southeast and identified as Tax Map Numbers 45.- 1-4, 5, 8.2, 12, & 13. The applicant proposes driveway realignments for Buildings A and B, minor facade modifications to Buildings A and B, and footprint changes to Building B. Changes to Building B include: elimination of the "tuck under" loading docks; narrowing and lengthening of the building by 19 and 88 feet, respectively, (overall square footage would remain the same); addition of walls in non-visible areas; and an increase in the number of dock doors from 98 to 121. Overall, the proposed changes would reduce impervious area within wetland buffer by 600 sq. ft., would reduce impervious surface area by 19,095 sq. ft., and would reduce the limit of disturbance by 8,420 sq. ft.
