A local law to amend Chapter 126 (Taxation), Article IV (Volunteer Fire and Emergency Services)

to extend partial real property tax exemptions to residents who provide volunteer fire
fighting and ambulance services to neighboring municipalities.

§126-15 Exemption Granted.

Pursuant to the provisions of § 466-c and §466-l of the Real Property Tax Law of the State of New York, as amended, the Town Board of the Town of Southeast hereby declares that, for assessment rolls prepared on the basis of a taxable status date occurring on or after January 1, 2003, the real property owned by one or more persons who are enrolled volunteer members of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service, or real property owned by a husband and wife, one of whom is an eligible volunteer member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service, shall be exempt from taxation to the extent of 10% of the assessed value of such property for Town, special district or county purposes, exclusive of special assessment. For a taxable status date occurring on or after January 1, 2025, such exemption shall be extended to any volunteer firefighter or volunteer ambulance worker who resides in the Town and provides such volunteer services to a city, village, town, county or school district neighboring the Town.

Paragraph A of §126-16 is amended as follows:

- A. The applicant resides in the Town of Southeast and the incorporated volunteer fire company or fire department or incorporated voluntary ambulance service provides services to the Town, or to a neighboring city, village, town, county, or school district.
